- The Buyer has had the opportunity to inspect the Boat or have it inspected, and the Buyer accepts the Boat in its current condition.
- If applicable, the Buyer undertakes to register the Boat with the appropriate jurisdiction within 6 days of signing this Sales contract. The Buyer undertakes to transfer the trailer registration at a Service Ontario centre and to pay the applicable transfer fees within 6 days of delivery.

### Check the applicable situation:

- this sale is made with legal warranty (the Seller warrants the Buyer the right of ownership and quality of the Boat).

- this sale is made without legal warranty, at the Buyer's risk (the Seller does not warrant the Buyer right of ownership and quality of the Boat, i.e. hidden defects).

This Sales contract shall be interpreted in accordance with the laws of the province of Ontario.
